Over the last quarter we made voting recommendations at 552 meetings (4,232 resolutions). At 302 meetings we recommended opposing one or more resolutions. We recommended voting with management by exception at four meetings and abstaining at zero meetings. We supported management on all resolutions at the remaining 246 meetings.

We made voting recommendations at 552 meetings (4,232 resolutions) over the last quarter.
